School Food Pantry - School-Based pantries are located on the grounds of a school to provide a more readily accessible source of food assistance to children and their families. As a need is identified by school staff, the pre-packed boxes containing a few days of emergency food, along with resource materials such as a pantry reference list and SNAP information, are distributed to the families in need.

After-School Snack Program - The After-School Snack Program provides nutritious, freshly prepared snacks to children in an environment that is safe, accessible, and convenient. Sites are located at organizations that provide after-school programming for youth such as Schools, the Boys and Girls Club, Hazel Hill & Salem Church Library.

Summer Food Service Program (SFSP) - With the Summer Feeding Program, children and teens ages 18 and younger, can continue to eat healthy, while school is out, at no cost. Participating sites serve grab & go meals for children to enjoy, just show up, receive a meal and enjoy it on the go. Parents and guardians are allowed to pick up meals even when their children can't be present.
